#### Portfolio Comments

The Brown Advisory Global Leaders strategy outperformed its benchmark, the Russell Global Large-Cap® Net Index, which was up 0.5%, during the month of June.

Investors brushed off persistent criticism about the efficacy of the Trump administration's economic policies and embraced encouraging corporate earnings. This was coupled with continued signs of a European economic recovery in the month of June, with global equity markets reaching new highs. The Federal Reserve's long-awaited interest rate rise resulted in a new area of equity market leadership, with financials outperforming during the period. Accordingly, JP Morgan and Charles Schwab were the two biggest contributors to performance during the period. Elsewhere Sherwin-Williams's closure of its Valspar acquisition contributed to the positive performance of the paint manufacturer's shares. Finally, Nike was another positive contributor to performance. The company released some encouraging results for its fourth quarter, driven by solid growth in Europe and China.

On the negative front, Alphabet was the main detractor from performance during June. After a strong run year-to-date, the Google parent's shares were weak after the EU imposed a €2.4 billion (approximately \$2.7 billion) antitrust fine on the company. Although we question the logic of the fine, the amount sought is manageable in the context of the company's cash flow and balance sheet. Elsewhere, investor concerns stemming from an expected reduction in long-term guidance resulted in weakness in

Starbucks' shares. Unilever was another detractor from performance during the period. The Anglo-Dutch food and personal care group's shares suffered from profit-taking in June after strong performance in the first five months of the year.

There were no additions or deletions to/from the Global Leaders strategy during June.

## **Terms and Definitions for Representative Account Calculations**

The **Average Weight** of a position or sector refers to the daily average for the period covered in this report of a stock's value as a percentage of the portfolio. The **Total Return** of an equity security is the sum of the return from price movement and the return due to dividend payments or other sources of income. Standard benchmark-, sector- and portfolio-level returns are the sums of the weights of each security multiplied by its return, summed and calculated daily and summed over the period covered by the report or by an otherwise-noted period. **Contribution To Return** is calculated by multiplying a security's beginning portfolio weight by its daily return and geometrically linking the security's daily contribution to return over the entire reporting period. **Return on Invested Capital** (ROIC) is the percentage amount that a company is making for every percentage point over the cost of capital (WACC). More specifically the return on investment capital is the percentage return that a company makes over its invested capital.
