Portfolio Comments

The Brown Advisory Large-Cap Sustainable Growth Composite rose 1.4% (net of fees), outperforming the Russell 1000[®] Growth Index in April, which rose 0.3%.

UnitedHealth Group Incorporated was the strategy's top performer this month. UnitedHealth had a strong first guarter and raised its guidance for the year. We believe that the company continues to execute well, specifically around the build out of its Optum business.

Thermo Fisher Scientific Inc. also had a strong return during the month. Thermo Fisher is a leader in producing emissions monitoring, radiation detection and water quality testing equipment. The company provides strategic supply chain services that help its biopharmaceutical clients comply with regulations, produce products safely and operate more efficiently. Red Hat, Inc. and Visa Inc. also posted strong returns during the month.

Edwards Lifesciences Corporation was the largest detractor in the portfolio. The company's transcatheter aortic valve replacement (TAVR) growth in the quarter was less than investors expected. As a result of the quarter's weaker growth, the stock sold off. Edwards remains the leader in TAVR, and we believe that the company has the potential to experience solid growth for the foreseeable future, as cardiologists increasingly recommend the procedure.

We eliminated our position in Starbucks Corporation during the month to fund our new position in Marriott International, Inc. We believe that Marriot offers stronger growth and upside potential over the long term than Starbucks. In our opinion, Marriott has more operating leverage inherent in its business model. Despite being one of the largest global hotel operators, the company still has a low market share which we believe bodes well for future growth for the company.

Terms and Definitions for Representative Account Calculations

The **Average Weight** of a position or sector refers to the daily average for the period covered in this report of a stock's value as a percentage of the portfolio. The **Total Return** of an equity security is the sum of the return from price movement and the return due to dividend payments or other sources of income. Standard benchmark-, sector- and portfolio-level returns are the sums of the weights of each security multiplied by its return, summed and calculated daily and summed over the period covered by the report or by an otherwise-noted period. **Contribution to Return** is calculated by multiplying a security's beginning portfolio weight by its daily return and geometrically linking the security's daily contribution to return over the entire reporting period.
