Portfolio Comments

The Brown Advisory U.S. Smaller Companies Composite fell 5.9% (net of fees) during February, outperforming its benchmark, the Russell 2000[®] Growth Index, which was down 7.2%.

Our relative outperformance comes at a time of heightened volatility in the market due to concerns over the spread of the novel coronavirus. During the month, the strategy's downside protection was largely driven by strong stock selection.

The portfolio's top contributor for the month was Zynga, a mobile game development and distribution platform. In February, Zynga reported their highest quarterly and annual revenue in addition to bookings in the company's history. Etsy and Waste Connections also positively contributed to performance.

The portfolio's top detractor for the month was Mimecast Limited, an international email and data security company specializing in cloud-based services. The company's shares fell after reporting fiscal year 2020 revenue growth guidance slightly below 20% at the midpoint. Following a positive analyst day a couple of weeks later, we believe the company remains well positioned for the future. Genpact Limited, a global professional services firm focused on delivering digital transformation, also trailed during the month. Over the course of the month, we eliminated one position and added one position.
